### VT Environmental Producer Responsibility (EPR) Legislation

Vermont's EPR laws require manufacturers to be responsible for the proper disposal of their products, thus reducing the disposal costs for towns. These products can be disposed of year round, free of charge, at the locations listed below and do not need to be saved for HHW events.

#### **Options for Other Items:**

**Propane Tanks:** recommend a swap out at your local retailer. Empty tanks can be taken to a HHW event.

**Tires:** return to local retailers and some transfer stations for a disposal fee.

**Large Appliances:** drop off at Hubbard Brothers, some local transfer stations. Fees may apply.

**Used Waste Oil:** Used motor oil is accepted at many local retailers in the area. Used oil filters are accepted at all HHW Events.

#### **Prescription Drug Takeback:**

The Drug Enforcement Association (DEA) sponsors a free national Drug Take-Back day.

## SWAC's Solid Waste Implementation Plan (SWIP)

All solid waste management entities in Vermont are required to have a SWIP. The SWIP is a comprehensive planning document meeting the State's standards for hazardous and solid waste. # Food Waste BANNED FROM VERMONT LANDFILLS

As of July 1, 2020, all residents and businesses are required to divert food waste from the landfill.

Food waste is one of the largest components of solid waste in U.S. landfills. Currently, 1/3 of food produced for human consumption is lost or wasted globally.

That's not the worst part. Food in the landfill does not break down or biodegrade due to lack of oxygen. It contributes to greenhouse gas emmisions and wastes the water and other resources it takes to grow the food. # The True Cost of Household Hazardous Waste

Many of the products we use in our homes today can be harmful to our health and the planet. Direct contact with or inhaling these chemicals, which are often labeled with words like "danger," "warning," or "caution," can lead to health problems such as irritation of the skin, eyes, or throat, headaches, and even cancer. These chemicals can also have a profound impact on the environment and are classified as household hazardous waste.

Household hazardous waste disposal costs continue to increase. In fact, we are anticipating an increase in the disposal cost of over 50% in the next year.

Towns are directly responsible for paying for the disposal of household hazardous waste responsibly.

Knowing this, disposing of household hazardous waste at a HHW event should be the last resort. Making environmentally responsible purchasing decisions can make a big impact in your community.

Here are a few ways you can make environmentally responsible purchases and help your town reduce disposal costs.

#### **Use What You Purchase**

If you need to purchase a household cleaner or drain cleaner, make sure to use it all.

#### **Purchase Alternative Products**

There are many natural cleaning product alternatives available at your grocery store or online. These cleaning alternatives are not classified as household hazardous waste. They are better for the environment and less toxic.

#### **Buy Only What You Need**

Don't stock up on household hazardous waste products. These cleaners have a shelf life and will "go bad". Purchasing the amount you need for the designated purpose rather than keeping these items on hand is an easy way to reduce waste.

#### **Simplify**

Use multi-purpose cleaners rather than having a full collection of specialized products.

#### **Give It Away**

Consider giving the usable, leftover products to a neighbor, community center, or church that can use it up if you cannot. It is much better to use up the product instead of disposing of it.

### Household Hazardous Waste Alterneratives

Instead of this:	You can use this:
Household Cleaner	Combine 1 tsp liquid soap, 1 tsp borax, 1 squeeze of lemon, and 1 qt warm water.
Ant Killer	Combine equal parts borax and sugar. Sprinkle around nest.
Disinfectant	Combine 1/4 cup baking soda with 1/2 gallon hot water.
Drain Cleaner	Pour 1/2 cup baking soda in drain followed by 2 cups boiling water.
Toilet Cleaner	Pour 1/4 cup baking soda into bowl and drizzle with vinegar. Let sit for 1/2 hour. Scrub and flush.
Mildew Remover	Dissolve 1/2 cup vinegar with 1/2 cup borax in warm water.
Carpet Cleaner	Sprinkle cornstarch or baking soda on dry rug and vacuum.
Furniture Polish	Mix two parts olive/vegetable oil to one part lemon juice. Apply mixture and let stand for several hours. Polish with dry, soft cloth.
Silver Polish	Soak items in 1 qt warm water mixed with 1 tsp baking soda, 1 tsp salt and a small piece of aluminium foil.

#### **HHW Event Schedule**

SWAC contracts U.S. Ecology for HHW collection eventts. Any SWAC resident can take their HHW to any of the collection events listed. Used waste oil will be accepted at the Rutland and Fair Haven designated collection areas during the events. Several local businessess also accept it for free year round.
